

RISK TO COMPANY STAFF BEING ASSAULTED	ENSURE THE STAFF HAVE A GOOD COMMUNICATION OPEN WITH MANAGEMENT.	2	1	1	ANY STAFF MEMBER IN RECEIPT OF ANY PHYSICAL VIOLENCE TO CONTACT MANAGEMENT AND THE POLICE AND REMOVE THEMSELVES, IF POSSIBLE, FROM THE SITUATION. IF POSSIBLE, TO RECORD THE INCIDENT ON A MOBILE VIDEO DEVICE.	Y

RISK TO COMPANY STAFF FROM CARTRYING / MOVING THE EQUIPMENT	ENSURE ACCESS ISSUES ARE DETAILED PRIOR TO THE HIRE AND THAT THERE IS ENOUGH ABLE STAFF TO COMPLETE THE HIRE. ENSURE NO STAIRS, DIFFICULT ENTRY.	2	2	2	STAFF TO LIASE WITH MANAGEMENT AND TO KNOW TO NOT GO AHEAD WITH A HIRE IF THE ENTRY IS UNSUITABLE AND A RISK TO THE HEALTH OF THE STAFF OR OTHERS. STAFF MEMBER TO TAKE PHOTOS AND VIDEOS AND REFER BACK TO MANAGEMENT FOR A DECISION IF UNSURE.	Y
INJURY TO FINGERS	ENSURING THAT PARTICIPANTS KEEP FINGERS CLEAR OF THE MECHANISM AT THE BOTTOM OF THE UNIT. THIS IS ESPECIALLY IMPORTANT FOR THE SURF HIRE AND THE SKATEBOARD WHERE SOME PARTICIPANTS TEND TO HOLD ON THERE.	1	1	1	STAFF TO ENSURE THEY TELL THE CUSTOMER NOT TO DO THIS AND STOP THE UNIT IF THEY SEE THIS BEIG DONE.	YY
DAMAGE TO ELECTRICS WITHIN A BUILDING	ENSURE THAT THE CUSTOMER KNOWS THE POWER SUPPLY REQUIRED FOR THE UNIT AND ENSURE THAT ALL EQUIPMENT IS PAT TESTED YEARLY.	1	1	1	WHEN SETTING UP EQUIPMENT ENSURE THAT THE ELECTRICAL EQUIPMENT CABLES AND WIRED ALL ARE IN TACT WITH NO DAMAGE TO THEM	Y
ELECTROCUTION FROM EQUIPMENT OR NEARBY CABLES	ENSURE THAT ALL EQUIPMENT IS PAT TESTED YEARLY.	1	1	1	WHEN SETTING UP EQUIPMENT ENSURE THAT THE ELECTRICAL EQUIPMENT CABLES AND WIRED ALL ARE IN TACT WITH NO DAMAGE TO THEM. ENSURE THERE ARE NO OVERHEAD CABLES ABOVE THE PARTICIPANT'S HEAD	Y
PARTICIPANT BECOMING FRIGHTENED	MONITOR EACH PARTICIPANT AS THEY GO ONTO THE UNIT AND ENSURE THEY FEEL COMFORTABLE AND THAT THEY ARE READY TO BEGIN THE RIDE	1	1	1	CONTINUE TO MONITOR THE PARTICIPANT AND IF THEY INDICATE THEY ARE NOT HAPP, STOP THE RIDE AND ALLOW THEM TO GET OFF	Y
PARTICIPANTS FALLING OUT OF THE UNIT	ENSURE THE INFLATABLE HAS A VALID SAFETY CERTIFICATE. INSPECT THE UNIT BEFORE EACH USE. ENSURE THE INFLATABLE IS ANCHORED CORRECTLY	1	1	1	KEEP THE ROTATION SPEED TO A LOW TO MEDIUM LEVEL TO AVOID ANY PARTICIPANTS BEING THROWN FROM THE RIDE. ENSURE THE UNIT REMAINS CLEAN AND NOT SLIPPERY.
